

# General Secretariat for the Missions and Evangelization

19. Upon the recommendation of General Definitory, the Secretariat of M & E should promote missionary vocations and a policy of "new" missions and "presences" in the Order and prompt reflection on our presence in the world and how to be more prophetic.

#### **GENERAL CHAPTER 2015**

#### Themes

- 20. The General Chapter of 2015 should deal with a few, but"clear" and "well-defined" issues.
- 21. The issues to be "considered" in view of the General Chapter should be grouped into the following thematic blocks:
- The identity of the Order: the life of union with God, fraternity and minority.
- Evangelical Counsels vows: reflection in the light of the Magisterium of the Church, while keeping in mind contemporary culture and current challenges.
- Formation: ongoing formation, formation to the service of authority and of Formators as well as formation for the mission.
- Presence in the world Evangelization: being attentive to the marginalized; social awareness; missionary and evangelizing policy; new presences; parochial

prophetic experience; interculturalism; and inter-religious dialogue.

#### Instrumentum laboris

22. The work of the General Chapter should be accompanied by a specific Instrumentum laboris, distinct from the Report of the Minister General; it should prepare and guide the reflection of the Chapter.

#### **Mandates**

23. It would be good that the mandates that the General Chapter will establish should be few, achievable, and sustainable.

# "Interdisciplinary" Study

- 24. The PCO suggests to the General Definitory, by involving the various Entities of the Order, to continue the reflection they started on the multidisciplinary work; it should also create an interpretive correlation of the data obtained with the structure of the values of our own life and mission. The results will be presented to the General Chapter of 2015.
- 25. The General Definitory, by involving the different entities of the Order, should continue the reflection on the interdisciplinary study of the Order, correlating it with the reports of the Visitator General and the sociological study on the Order.

# THE CONFERENCE OF PROVINCIAL MINISTERS

Structure of the Conference

12. The General Chapter should clarify the "structural role" of the Conferences based on what is provided in the General Constitutions (Art. 227 § 1).

## Composition of the Conference

13. In the Erection or restructuring of a Conference of Provincial Ministers and Custodes, the General Definitory may depart from the minimum number of Entities provided by Art. 200 § 4 of the GGSS, provided that the Conference itself is composed of at least 500 solemnly professed Friars.

Term of Office of the President of the Conference

14. In order to improve the quality of the leadership of the Conference of Presidents, the term of office for the President should be of three years.

# President of the Conference

- 15. It is proposed to amend Art. 204 § 2 of the GGSS, so that the Presidents of the Conferences can be a Provincial Minister or a Custos (whether of an independent or dependent Custody).
- 16. In Accordance with Art. 201b of GGSS, the Presidents of the Conferences, in meetings with the General Definitory, should be

consulted on matters of greater importance to the Order.

# SECRETARIATS AND OFFICES OF THE GENERAL CURIA

Reflection on the Secretariats, Offices of the Curia and International Councils

17. The General Definitory should verify the current situation of the two General Secretariats (F&S and M&E) and other offices of the Curia, bearing in mind the new dimensions and the powers delegated to them by the Order, redesigning the structure, nature, composition, objectives, and operation. In this review, the review of the respective International Council should also be inserted.

General Secretariat for Formation and Studies

18. Within the Secretariat General for Formation and Studies, the General Definitory should establish the figure of the Moderator General for Ongoing Formation, with the specific aim to lead the Conferences and Entities, while focusing especially on the Study Centers of the Order.

Note: After a brief moment of silence, the friars shall discuss and present their reactions on the following proposals made by the Plenary Council of the Order which shall be presented at the General Chapter in 2015 before they become Capitular decisions.

# DISCUSSION ON THE PROPOSALS

#### **ELECTION OF A LAY BROTHER**

Election of the solemnly professed lay brother as a legitimate voice at the General Chapter

- 1. Each Conference of Provincial Ministers shall elect a laybrother as a legitimate voice to the General Chapter (cf. GGSS 142 §3). Among the Conferences with more than 500 solemnly professed friars a second lay brother per Conference is to be elected, in order to give greater meaning to the number of lay brothers being represented.
- Each Conference shall determine the procedures for the appointment of

the lay brother (or lay brothers) who will attend the General Chapter.

#### MINISTER GENERAL

Term of Office

3. The office of Minister General has a duration of six years, renewablefor another six years. A re-election will require the qualified majority (i.e., two thirds of the votes cast in the first ballot).

Vacancy of the Office

4 In case of vacancy of the office of the Minister General in the "first three-vear period", the Minister shall be elected in accordance with the current legislation within two

months (cf. GGCC 201 §1), but with the previous consultation and presentation of candidates by the Conference. If the office becomes vacant in the "second three-year period", he will be replaced by the Vicar General ad complendum sessennium.

## Visiting the Entities

5. The Minister General, during the sixyear period, should possibly visit all the Entities of the Order, spending enough quality time with them. To help achieve this – because of the symbolic value which the visit has to strengthen the sense of belonging to the Order and in order to give confidence and hope to the Friars it is considered important to prepare for the visit. For this reason, it is determined that the General Definitor and the Offices of the General Curia should cooperate in preparing for the visit, stating the contents and topics to be addressed in dialogue with the Entity.

# Entities and Dependent House

- 6. The Entities and the Houses dependent "directly" on the Minister General should be entrusted by "ordinary government" to the responsibility of the Vicar General, so as to "facilitate" the service of the same Minister to the universal fraternity.
- 7. The General Definitory should constitute a commission for the study of juridical and legal issues (civil and criminal) of Houses and entities directly dependent on the

Minister General, in order to protect the Order and the same person of the Minister General.

#### PROVINCIAL MINISTER AND CUSTOS

Term of office

- 8. It is proposed to amend Art. 182 of GGSS, namely, that the Provincial Minister may be re-elected for a second term, for the duration of six years, but on the condition that it has the qualified majority (i.e., two thirds of the votes cast in the first ballot).
- The term of office of the Custos of an "Autonomous Custody" is equated to that of the Provincial Minister.

Formation of Provincial Ministers and Custodes

- 10. The General Definitory should continue to organize formation sessions for the new Provincial Ministers and Custodes at the beginning of the mandate.
- 11. The General Definitory should provide, during the course of the accompaniment/ mandate, an assessment for the service provided.
